3. Purposes of processing and legal basis for processing

We will process your personal data:

The legal basis for processing your personal data is:

- University recruitment proceedings conducted under the provisions of the Law of July 20, 2018. Law on Higher Education and Science - Article 6(1)(b) of the GDPR

4. Recipients of your data

We will transfer your personal data to:

- to our suppliers to whom we outsource personal data processing services, such as IT service providers. Such entities process data under contract with us and only in accordance with our instructions.

5. Your rights related to personal data processing and automated decision-making

You have the following rights related to the processing of personal data:

- the right to withdraw consent to data processing,
- the right to access your personal data,
- the right to request rectification of your personal data,
- the right to request the deletion of your personal data,
- the right to request the restriction of the processing of your personal data,
- the right to object to the processing of your data on the grounds of your particular situation - in cases where we process your data on the basis of our legitimate interest,
- the right to transfer your personal data, i.e. the right to receive your personal data from us, in a structured, commonly used machine-readable computer format. You can send the data to another administrator or request that we send your data to another administrator. However, we will do so only if such a transfer is technically possible. You have the right to data portability only as to those data that we process under contract with you or on the basis of your consent.

The right to withdraw consent

To the extent that your data is processed on the basis of consent - you have the right to withdraw your consent for data processing at any time. Withdrawal of consent does not affect the lawfulness of the processing that was carried out on the basis of your consent prior to its withdrawal. You can withdraw your consent by sending a statement on withdrawal of consent to our mailing address, our e-mail address.

The right to file a complaint with the authority

You have also the right to lodge a complaint with the supervisory authority in charge of personal data protection, i.e. the President of the Office for Personal Data Protection.
